



2020 FROSTBITE FESTIVAL TOURNAMENT POLICIES & PROCEDURES

Welcome to the Frostbite Festival. Please familiarize your team, coaches and parents with the formats and requirements for this tournament.

All teams are seeded into groups of four teams for the "First Round" of pool play, which starts at 8:00 am, Saturday. All teams will be seeded into new four team groups for the "Second Round" of pool play, which will start immediately after the results from the first wave are posted on Saturday and conclude on Sunday. After the second wave of pool play all teams will be seeded into the "Third Round" of single elimination playoff brackets.

All matches will be the best 2 of 3 rally score sets. The first two sets will be 25 points, no cap win by two. The third set, if required, will be a set to 15, no cap win by two points. Teams will switch courts in the third set when one team has scored 8 points.

Teams will be seeded to the next round of play according to the match won/lost results in their pool play.

TIE BREAKER PROCEDURES

- 1. Two way ties:
 - a. Result of Head to Head pool play match
- 2. 3 or more teams tied:
 - a. Set percentage (Sets won/total sets played)
 - b. Point Differential based on that entire pool play
 - c. Coin Toss

FACILITY FOOD AND BEVERAGE RULES - Teams will not be allowed to set up team "buffets" or bring in electrical devises to serve warm food. Concession stands will be available. COOLERS WILL NOT BE ALLOWED IN THE BUILDINGS. Only water and sports drinks, in plastic bottles, may be brought to the player's bench area for use during a match.

TRAINER AT NVC – A certified Sports Medicine Trainer from Mayo Sports Medicine is available to treat and advise on sport injuries. Ice, tape, wrap and treatment is provided to players at no cost.

BREAK ROOM AT EACH VENUE – A break room at each venue is stocked with water, fruit, rolls, treats, snacks and lunch food for Officials, Coaches and RYVA Staff at no cost, Enjoy.

BALLS – Game balls and warm up balls in portable carts are provided for your use. **Do not bring warm up balls to the event.**

The 2020 USAV Rules and NCR modifications will apply to all matches with the following clarification's and exceptions:

- The first match on Saturday will start at 8:00 am.
 The first match on Sunday will start at 9:00 am.
 All other matches will be played in order. Teams are to be ready to play when their match is sequentially ready to be played.
- 2. A 10 min. warm up the 2-4-4 format will be used for ALL matches. The first two minutes will be for ball handling, followed by 4 minutes on the court for the serving team and then 4 minutes for the receiving team. The referee will conduct a coin toss for the first set and if necessary the third set. Court officials will use the scoreboard clock to time warmups and time between sets.
- 6 Players to Play: Teams not having six players when called to the end line at the beginning of a match will forfeit the first set. The team will forfeit the match if they do not have six players within ten minutes after forfeiting the first set.
- 4. Protest: Only rule interpretations can be protested, not judgment calls made by the officials. A protest must be filed at the time of the infraction and settled before the set continues. A protest will be resolved by a committee of the First Referee, Head Official, and the Site Director. The committee will vote to deny or uphold the protest. Their decision is final.

OFFICIALS

"Up" referees will be provided for all matches. When scheduled, each team will provide two line judges, a scorekeeper, a scoreboard operator, a libero tracker and a 2nd (Down) referee. Teams must be on time for their refereeing responsibilities as if they were playing, see Exception 4, above, for penalties. The 2ND Ref can be a coach or a player with the team coach assisting from the scorer's table or standing near the player ref.
